PUBLIC HEARING

NEW YORK CITY DEPARTMENT OF EDUCATION (DOE), THE NEW YORK CITY SCHOOL CONSTRUCTION AUTHORITY (SCA) PROPOSES THE ACCEPTANCE OF CONSTRUCTION FUNDING FOR RENOVATION AND EXPANSION OF AN EXISTING BUILDING THAT CURRENTLY HOUSES DOE'S MIDDLE COLLEGE HIGH SCHOOL SUCH THAT IT WOULD ALSO ACCOMMODATE DOE'S INTERNATIONAL HIGH SCHOOL. THE EXPANDED FACILITY WOULD ACCOMMODATE A TOTAL OF APPROXIMATELY 820 STUDENTS IN GRADES 9-12. DESIGN AND CONSTRUCTION OF THIS PROPOSED PROJECT WOULD BE CONDUCTED PURSUANT TO DOE FIVE-YEAR CAPITAL PLAN FOR FISCAL YEARS 2010-2014. THE PROJECT SITE IS LOCATED AT 45-35 VAN DAM STREET, ON THE SOUTHERN PORTION OF THE BLOCK BOUNDED BY QUEENS BLVD TO THE NORTH 32ND

PLACE TO THE EAST, 47TH AVENUE TO THE SOUTH, AND VAN DAM STREET TO THE WEST IN THE LONG ISLAND CITY SECTION OF QUEENS.
